Thank you for boarding your pet at Conway's Pooch Parlor Inc. We feel we provide a safe and healthy environment for your pet, thus we will not be held responsible for damage from disease, death, theft, fire, running away or any other unavoidable mishap. Bills are calibrated the same as any hotel, you are always charged for the day your pet arrives. Monday-Sat.: pets picked up before 9 A.M. will be charged for a ½ day. After 9 A.M. you will be charged for the day. You will always pay for Sunday. Medications will be given at an additional charge of \$1 per day. Additional food preparations are \$1 per day. We ask you to bring your own food, if not, a \$1 per day charge will be added to your invoice. Please advise us if your dog cannot have other foods or treats. Non-housebroken pets will be charged \$4 extra while special need pets will be charged an extra \$2 per day. We do not board in heat females. If she comes into heat while boarding you will be charged an additional \$25 per day. We will not be responsible for accidental breeding. We are not responsible for the destruction of any articles left with your pet. If your pet arrives with fleas/ticks, he/she will be treated at the owner's expense. The customer agrees to notify us in advance if there are any changes in your pet's drop-off/pick-up date/time. No pet will be released until all charges are paid. Pets left uncalled for seven days after scheduled pick-up, as noted, shall become the property of the kennel and may be sold, given away or euthanized. Senior Pets: When older pets are boarded they can become stressed, because of the removal from their home environment. This stress can cause latent physical conditions, including (but not limited to): heart, liver, and kidney disorders) to become active. These disorders can result in illness or death of the pet. The owner/agent has read and understands the above. The owner/agent for the pet agrees not to hold this boarding facility and/or its owners responsible for the illness or death of their pet or any expenses incurred because of the illness or death of their pet. The owner/agent gives Conway's Pooch Parlor Inc. authority to obtain veterinarian care when the owner/agent or emergency contact cannot be reached. Should any pet become ill or need medical attention, we reserve the right to administer aid and/or care by our kennel veterinarian, Hartzell Veterinary Service, or the emergency vet clinic. Any expenses shall be the sole responsibility of the owner and paid promptly. While staying at the Pooch Parlor your dog's picture/video may be taken. These pictures/videos may be used for advertising or commercially. By signing this contract the owner/agent relinquishes all rights to all photographs/videos taken. Proof of updated shot records are required for all pets. Shots required for dogs are Distemper/parvo, Bordetella and Rabies. Cats: Distemper, Leukemia, and Rabies.
